All RDOS facilities except landfills, are closed until further notice. This includes satellite offices, recreation facilities and programs, and community halls. Residents are asked not to attend area Fire Halls.

Landfills remain open but customers are asked to use curbside collection for garbage, recycling and yard waste. Payments are being accepted by credit or debit only. Cash will not be accepted.

For the safety of staff and the public, please avoid visiting the landfill at this time.

If you are self-isolating, under quarantine, or if you are currently ill - please stay home.
