Wildfire

Pursuant to Section 13 (1) of the BC Emergency Program Act an **Evacuation Order** has been issued by the Regional District of Okanagan-Similkameen to protect the health, safety or welfare of a person or to limit damage to property due to: Wildfire.

Members of the RCMP and other agencies under the direction of RCMP will be expediting this action.

The **Evacuation ORDER** is in effect for the properties listed in Schedule 1 located in the following locations:

- Electoral Area “C” addresses on Yellowbrick Road and Willowbrook Road
- Electoral Area “G” properties on Grand Oro Road
- Electoral Area “I” Grand Oro Road east along to White Lake Road

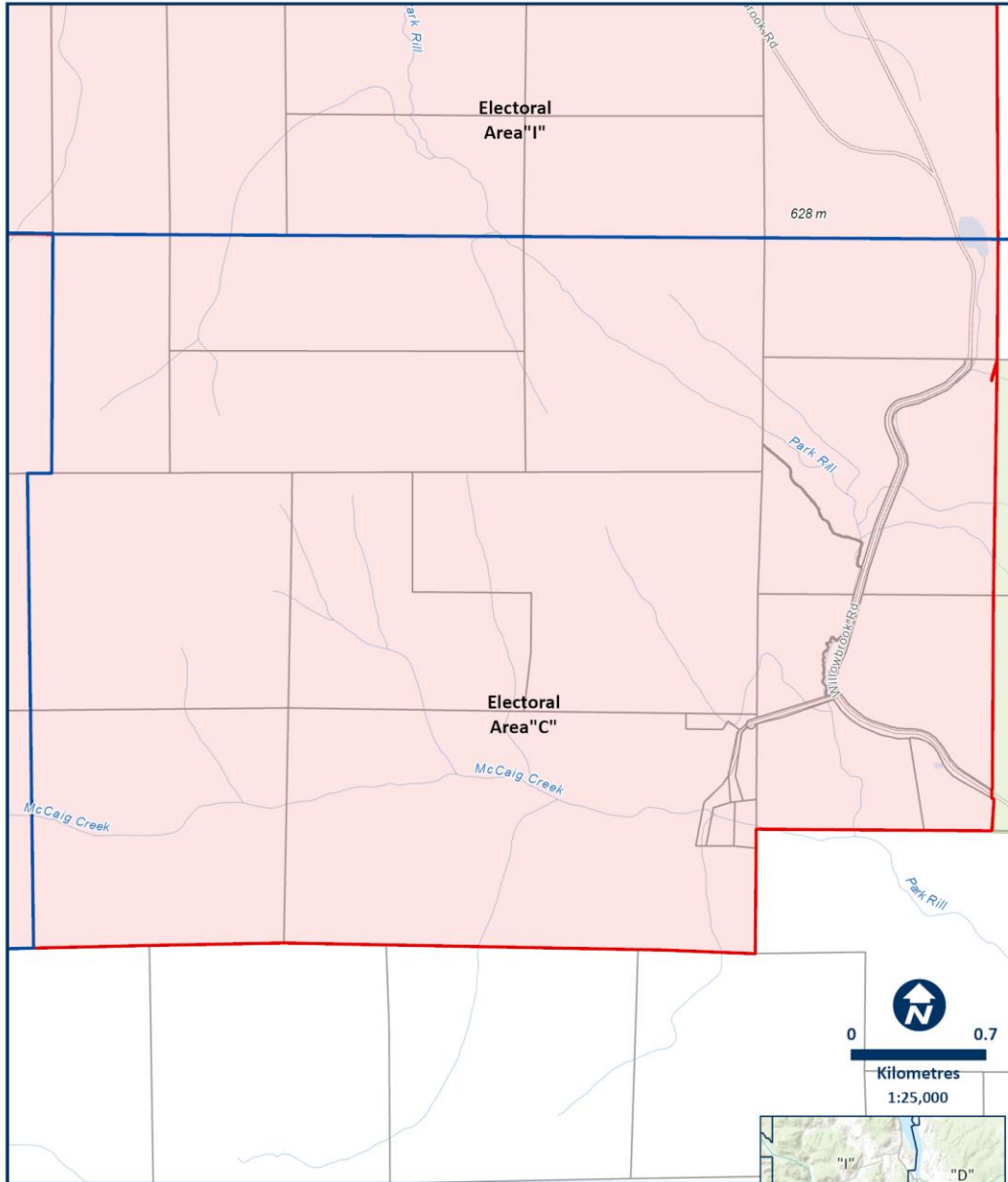

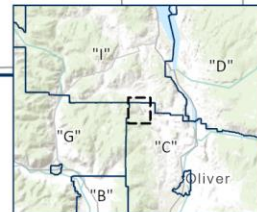


Schedule 2 - Evacuation Order Maps ELECTORAL AREA "C"

WHAT YOU SHOULD DO:

- You must leave the area **immediately**.
- Follow directions of emergency responders and travel designated or safest route available.
- Register online at ess.gov.bc.ca
- Go to the **ESS Reception Centre at 199 Ellis Street, Penticton** –if you require immediate assistance
 - Due to a shortage of commercial/hotel accommodation, consider making arrangements to stay with family or friends if possible.
 - Take pets with you if you can.
 - **For ESS Support by phone, call 250-486-1890**
- If you need transportation assistance, call **RDOS EOC: 250-490-4225**
- Gather your family; if you have room, take a neighbor or someone needing transportation.
 - Do not use more vehicles than you have to.
- **Do not turn off your natural gas. FortisBC will turn off natural gas service as needed.**
- Store your Firearms in accordance with Section 118 of the Firearms Act.
- Close all windows and doors.
- Close gates (latch) **but do not lock**.

WHAT TO TAKE:

- Critical items *only if they are immediately available*:
 - government-issued ID
 - medications
 - eyeglasses
 - valuable papers (e.g. insurance, credit, and mortgage information)
 - immediate care needs for dependents
- Pets in pet kennels or on leash.
 - **Pet owners and hobby farmers** with concerns for their animals *may* contact:
 - **Animal Emergency Response Team (ALERT): 250-809-7152**
 - **Commercial Farmers** who require assistance *may* contact:
 - **RDOS EOC: 250-490-4225**

YOU MUST LEAVE THE AREA IMMEDIATELY

At the Reception Centre – Emergency Support Service (ESS) volunteers are able to assist you to meet your basic needs by providing service for up to 72 hours. This may include coordinating food, clothing, lodging and transportation.

- *If you are not able to attend the reception center and require support, call 250-486-1890.*
- *An ESS volunteer will return your call.*

ESS is a safety net program available when alternatives such as family, friends, and insurance cannot be accessed. ESS is not offered if insurance is accessible. In situations where insurance exists, but cannot be immediately accessed, interim support may be provided.
